NATIONAL BOARD OF DIRECTORS ELECTION 2010 PRIMER

A. When will the election of Directors of National Board be held?

Answer: At the annual membership meeting on March 27, 2010. Venue has not been determined.

B. How many Directors of National Board will be elected? What is the term of office?

Answer: Fifteen (15) Directors of National Board will be elected who will serve for a term of 2 years.

C. What are the qualifications of the Directors of National Board? Who may nominate?

Answer: A member must be *active* and in *good standing* to nominate. A member may be nominated as director of National Board if he/she is active and in good standing, has been attending meetings and/or participating in events sponsored by Annak, and has paid membership fee.

D. Are the directors of the current National Board eligible for re-election.?

Answer: Yes. The current directors may serve 2 consecutive terms.

E. When can I nominate and how will I nominate?

Answer: Nomination is now open and will close on December 31, 2009. You may nominate by completing the *Nomination Form* online or by mailing the completed form to Annak national office postmarked December 31, 2009. The Nomination Form is attached and can be downloaded from Annak website: www.annakticandon.com.

F. Should the nominee accept the nomination? What is the period to accept the nomination?

Answer: **Yes.** Only accepted nominations will be included in the election ballot. The nominee will be advised in writing about his/her nomination and must accept the nomination within 30 days from the date of the nominating letter, but no later than January 31, 2010.

G. How do members vote for the Directors of National Board?

Answer: a). Election ballots listing the names of the candidates will be mailed to the general membership no later than 30 days before the election date. The Election ballots must be received on or before election date.

b) Members attending the annual meeting will vote by secret ballot.

H. Who will elect the officers of the corporation?

Answer: Officers of the corporation will be elected by the newly elected Directors of National Board immediately after the election.

I. Who will conduct the election and set the rules governing the election.

Answer: Election Committee composed of non-candidates will conduct the election and set the rules, and will proclaim the elected directors and officers of the corporation.
